### **Summary**

This was a focused inspection and, on this occasion, we did not consider the environment, care and development and leadership and management in detail.

Children are happy, settled and enjoy their time at Cylch Meithrin Pontarddulais. They have many opportunities to follow their own interests and make choices. Children experience positive interactions with the adults around them and know that they will be listened to. They enjoy a range of opportunities to learn, play and develop.

Staff understand their role and promote good hygiene practices and support children's well-being. They use positive behaviour management strategies with children. Staff work consistently to provide children with a positive learning and play environment.

People who run the setting have implemented effective changes to the service. They have made improvements to their processes and have provided evidence to show that they have met both priority action notices.

#### Well-being

Children have some opportunities to make choices. They make decisions about where to play, what to play with and when they move from one activity to another. For example, once the children had finished their snack, they left the table to begin their play.

Children are content and express enjoyment. They are settled, happy and express themselves confidently. Children have a sense of belonging. They are familiar with all the adults who look after them and go to them for reassurance, to share their play and learning. For instance, children happily sat with staff and went to show them what they had been doing during their play. Children are beginning to form friendships and are familiar with routines. They joined in with singing on the mat and knew what to do when staff said it was "amser tacluso".

Interactions between children and adults are positive. Children consistently hear encouragement from staff and follow their instructions and requests. For example, staff asked a child to put their bottle back into their bag once they had finished drinking, and they were very willing to do it. Children co-operate and younger children are beginning to share. They share resources with each other and show an interest in what their friends are doing.

Children are engaged in their play and learning. They happily complete adult led activities as well as following their own interests. They change and move resources to different areas or use them in a different way. For instance, one child used the Christmas decorations as part of their small world Peppa Pig character play and used the hoops and bean bags in their own made-up game.

Children enjoy a reasonable selection of appropriate opportunities indoors including social, creative, language and physical play. They are engaged for an age-appropriate amount of time, with some children concentrating on more challenging activities. For example, one child spent a good amount of time practising cutting play dough after staff had showed them what to do with the scissors. Children have many opportunities to initiate their own play and to influence their tasks and activities because there is a good balance of child and adult-led activities.

#### **Care and Development**

As this was a focused inspection, we have not considered this theme, in full.

Staff are implementing procedures to promote healthy lifestyles, physical activities, personal safety, and well-being. They follow robust cleaning and good hygiene practises including wiping tables before snack and following good hand hygiene after wiping noses. Staff are fully aware of risks and manage these well. For example, when moving up and down the stairs and between rooms, the staff are consistently talking and reminding children about holding onto the rails and following each other. They ensure that children's well-being is promoted.

Most staff support children to speak or express themselves well as they receive a consistent response/interaction. They use lots of positive reinforcement including 'da iawn', the use of thumbs up, individual praise and words of encouragement. Staff show a genuine interest in what the children are saying, reacting accordingly or asking follow up questions. For instance, a child asked a staff member for help, but they were already helping another child. The staff member explained "I am just helping this child, then I will help you, ok?" The child was satisfied with this and waited for help. Staff react to children's non-verbal communication and promote the Welsh language consistently.

## **Environment**

As this was a focused inspection, we have not considered this theme.

#### **Leadership and Management**

As this was a focused inspection, we have not considered this theme, in full

Cylch Meithrin Pontarddulais has focused leadership who are working effectively to develop and improve the setting. People who run the setting have a clear vision and share this with others. Since the last inspection, they have made some positive changes to their practises and have begun to implement the recommendations from the last inspection. For example, they now have a clear record of when staff are looking after children and when they are on breaks or the school runs.

People who run the setting follow a safe recruitment process to safeguard children. They have satisfactory systems in place to complete suitability checks for members of staff and volunteers. They ensure that evidence is kept for inspection. People who run the setting have a developed and implemented a suitable supervision process. Staff said they feel happy and supported by the people who run the setting and find the supervision process helpful as they can raise issues and discuss their professional development needs.
