Summary

This was a focussed inspection and, on this occasion, we did not consider the environment in detail.

Children are happy at the setting. They have formed close, warm relationships with the childminder. They benefit from an appropriate range of toys, resources and equipment to promote their learning and development. The childminder shows improvements with regards to fire drill and updating of mandatory training. All Priority Action Notices issued at the last inspection have been closed down.

Observations were limited due to there only being one child present at the time of the inspection.

Well-being

Children have control over how they spend their time at the service. They have opportunities to independently access a range of resources which are easily accessible to them. Children are listened to and responded to appropriately by the childminder.

Children develop positive relationships with the childminder and her family. We saw a child sitting at the table with the childminder drawing a map of where the 'treasure' was hidden then using the map to find it.

Children approach the childminder spontaneously to seek reassurance and support. We saw a child seek out the childminder to tell her that they had found the treasure she had hidden.

Children are developing their confidence and independence. They access resources that interest them, and they enjoy playing alone. Children proudly showed us their toys and a book they had made themselves with pirate coin rubbings and treasure maps.

Care and Development

The childminder keeps children safe and healthy. She understands the procedures in place to safeguard children and since the last inspection, she has completed safeguarding training. She is confident in raising concerns to the relevant teams within the local authority. The childminder has also completed regular fire drill practices, in line with the regulations, since the last inspection.

Covid-19 restrictions such as parents not entering the home and increased handwashing are still in place. We saw a child encouraged to wash their hands after using felt pens.

As a result of the improvements made with regards to the childminder attending safeguarding training and carrying out regular fire drill practices, the Priority Action Notices issued at the last inspection have been closed.
