## **Summary**

Children direct their own play and learning and are confident communicators to voice their needs and opinions. They are settled and relaxed in the care of the child minder. Children have formed close friendships and interact positively with one another. They are developing good all-round skills, in line with their age and stage of development.

The child minder implements particularly good policies and procedures to promote children's health and safety. She has completed many training courses, including first aid and safeguarding, and implements what she has learned effectively in her practice. Hygiene practices and routines are thorough. She provides an interesting and stimulating environment through well-planned and resourced activities.

The child minder's home is generally well maintained. She considers safety aspects appropriately considered and provides a safe and suitable space for the children. It is resourced with an excellent variety of equipment and furniture, to meet the needs and interests of all children.

The child minder is knowledgeable about her regulatory responsibilities and keeps up to date with best practice. She annually reviews her service to identify areas for improvement, when necessary. The child minder is motivated and committed to continuous professional development and undertakes extensive training. She has very good partnerships with parents and has developed useful contacts with the local authority and other professional bodies to support her.

**Well-being****Good**

Children express themselves confidently because they know their ideas, wishes and choices are listened to. Good questioning throughout the day encourages them to make informed decisions about their play. They select toys they want to play with from the many items within easy reach. We heard the children chat and arrange their play together. They readily approach the child minder to ask for support and alternative toys and resources. For example, one child wanted to have certain craft stickers for a card she was making, and the childminder provided it.

Children feel safe and are happy and relaxed in the child minder's care. They told us they really enjoy attending and talked excitedly about what they had been doing. They move around the various play areas with confidence, moving toys and resources to where they want to play. They respond very positively to praise, developing elevated levels of self-esteem.

Children take the lead in their play and actively follow their interests. Children access a very wide range of activities that are readily available. Most children told us that they enjoy spending time playing outside on the patio area, in the small playhouse and trampoline. They enjoy relaxing in the playroom, playing with games, large dolls equipment, other small world items and craft resources. They sit at tables enjoying craft and numerous other interesting activities. They readily engage in well planned themed activities based on children's interests which motivates and engages them in positive learning experiences. For example, they enjoyed all engaging in a card making craft activity and discussed the ideas they and for their card designs together and asked each other opinions about where to place decorative items on their cards.

Children thrive and make good progress in their learning and development. They have very good opportunities to develop their independence. Children from an early age learn skills to be able to manage tasks for themselves including washing hands and eating their food independently. Children know the house rules including where they can and cannot go to play and they follow these well. They enjoy their play immensely, as they are interested in the fun and challenging activities provided as well as the many free play opportunities available. They enjoy sitting chatting to their friends and learning new dances. Skilful questioning such as, 'do you think...?' and 'what if...?' encourages the children to think about things for themselves. Children are successfully learning key information about numbers, the weather, and the days of the week.

**Care and Development****Good**

The child minder is experienced and undertakes regular ongoing training to support her to be effective in her role. She has very good policies and care practice measures in place to effectively safeguard and promote the welfare of all children in her care and keeps these under review. The child minder gives safeguarding a high priority and has current certificates in various safeguarding areas, as well as child protection. She is confident in her knowledge of child protection issues and the procedures to follow with any child welfare concern. She is currently in the process of completing an updated paediatric first aid training course. The child minder has undertaken a very wide variety of courses in the last year, covering all aspects of care practices and business matters, including changes to the curriculum in Wales. The child minder promotes healthy lifestyles and provides children with fresh drinking water and healthy snacks. She sits with them when they eat, encouraging them to eat the healthier options when having snacks or tea. The child minder plans many activities outdoors to ensure children are physically active each day.

The child minder adopts a calm, positive approach to managing children's behaviour and is enthusiastic and kind in her interactions. She uses her experience and training to manage interactions effectively. The child minder described how she explains to children what the expectations of behaviour are, ensuring that they are clear about the house rules. The child minder knows children's individual personalities well and monitors and motivates them to develop resilience and self-discipline. She uses rewards the children with positive reinforcement strategies when appropriate to promote positive outcomes.

The childminder promotes children's play and learning very well. There is a robust system in place to gather information about the children's needs before they start, and to monitor their development in the form of individual assessments for children under 3 years and maintains an evidence scrap book to support their development which is shared with the parents and carers. The child minder has a very thorough method of planning activities and ensures resources to support themes and activities are plentiful and interesting. The child minder regularly takes photographs during activities. These show children enjoying an exceptionally broad range of activities covering all areas of learning, including multicultural celebrations. The child minder provides many opportunities for children to work things out for themselves and solve problems through for example, games and craft activities. The child minder uses resources effectively to encourage children to think about what might happen next, why, and when. The child minder is not a Welsh speaker but makes efforts to promote the Welsh language and culture often during the day.

**Environment****Good**

The child minder generally ensures the premises are safe and secure. She implements good policies, procedures, and risk assessments to maintain a safe and hygienic environment. These include cleaning schedules and hygienic procedures, in response to the Covid-19 pandemic. Appropriate measures are in place to mitigate risks, such as safety gates. The child minder has improved the outside area significantly and laid a large new patio area in recent years and she has recently further expanded the risk assessment to ensure children are safe and secure, by being constantly supervised when using this area. The gas safety check is up to date and the child minder practises their emergency evacuation procedures regularly. She told us that she has considered how to evacuate children from all areas, and this is reinforced during practice evacuations.

The child minder offers a child-centred environment that is friendly and inviting. Resources in the kitchen, playroom and outdoors are easily accessible to children. The toilet is located off the main playroom and has been designed with slightly lower level toilet and sink for the children's use and the child minder supports children to use the facilities as required. Play takes place in the designated playroom/dining area and in the rear garden. There are areas to rest and relax with appropriate eating facilities, and furniture to provide a suitable environment for the children. The child minder displays children's work prominently, in the play areas, giving the children a sense of pride and belonging.

The child minder provides an environment that supports children to reach their full potential. She has a wealth of high-quality toys and resources that provide excellent play opportunities and challenges for children. The resources promote their learning, and engage their interests very well, such as role-play, reading and fine motor skill activities. Resources and play areas are very interesting and are changed regularly to enhance current themes and topics.

**Leadership and Management****Good**

The child minder is committed to providing a very good quality service for both children and parents. She is enthusiastic about supporting children to thrive and reach their full potential. The statement of purpose contains useful information for parents about the service. She manages her business well and reviews policies and procedures regularly. All necessary paperwork is in place and is well organised. For example, the child minder maintains accident and attendance records clearly. Some improvements were made to policies such as the statement of purpose and complaints policy during this inspection.

The child minder has a good system in place to review her service. She completes an annual quality of care review on all aspects of her service. This reflects on feedback from parents, outlines her strengths and any areas to develop across all themes. She is reflective and continually looks at ways she can improve and build on her already good quality service. This includes seeking out information and training regarding updates to relevant legislation such as Wales Safeguarding Procedures and New Curriculum for Wales. The child minder is receptive to advice from other professionals and is quick to make any changes to further improve the service and experiences of children.

The child minder has close partnerships with parents, who speak very highly of her service and the care she provides for their children. She has comprehensive information from parents about their child's individual needs prior to care commencing. The child minder keeps parents well informed about their child's experiences and development through various methods of communication such as daily verbal information, diary and Whatsapp. Regular conversations, photographs and written observations help parents understand how well their child is progressing. The child minder has a good relationship with the local authority childcare team, who provide support, information and training as she is also an active member of local childminding group in the area.
