Summary

This was a focussed inspection.

Children are happy, settled and enjoy their time at the playgroup. They have adequate choice and opportunities to develop different skills and become independent. We saw positive, caring and affectionate interactions between staff and children. The setting has made improvements in the provision of play choices which are suitable for the age range of children attending. Arrangements for meeting the individual care needs of children has improved overall. Leaders understand their responsibility to safeguard children by making proper provision for their care and welfare and now provide them with the individual support required for their particular health need or disability. They have actioned some of the good practice recommendations made at the last inspection although we did not focus on these in detail.

Well-being

Children feel safe, happy and valued at the playgroup. They are free to choose what they want to play with and the toys and activities are appropriate for their age and stage of development. They frequently approach staff and enjoy spending time playing with them alongside their friends. For example, we heard lots of laughter at the investigation table when children counted the small toy bird's eggs as they placed them into their nests.

Children feel safe and secure as they are familiar with the routine of the playgroup. For example, they came into the playgroup calmly with big smiles on their faces as they were greeted by their familiar key workers. They selected toys and activities to play with and settled immediately.

Children develop positive, healthy relationships with their friends and staff and are happy to seek support when needed. Children behave very well and enjoy receiving praise from staff for good manners and being kind and helpful. The playgroup provides a calm and relaxed atmosphere.

Children's self-help skills are developing very well. They often wash their own hands and tidy up after play. They do this independently with support from the staff when needed. Children are gaining confidence in using simple Welsh words and phrases while answering simple commands and in songs.

Care and Development

This was a focused inspection, we have not considered this theme, in full.

Staff understand their responsibility to ensure that each child is provided with the individual support required for their particular health need or disability. We saw that children's individual care and behaviour management plans have been developed which has made a positive impact on their wellbeing. Staff have been provided with appropriate training which has impacted positively on the children's care.

Environment

This was a focused inspection, we have not considered this theme, in full.

Leaders understand their responsibility to ensure that all required safety checks for the premises are updated and available for inspection. We saw evidence that the gas and electrical safety checks for the building have been completed in the required time frame.

Leadership and Management

This was a focused inspection, we have not considered this theme, in full.

People who run the playgroup understand the importance of managing staff performance and ensuring that they have useful opportunities to discuss and reflect on the quality of their work. We saw that staff have now receive updated supervision to establish clear improvement targets for their development.

Recommendations to meet with the National Minimum Standards

- R1. Develop the planning for activities to help children practice new skills.
- R2. Ensure that the environment offers a good choice of activities and resources suitable for all age groups of children attending.
- R3. Ensure all risk assessments are reviewed regularly and any potential hazards are addressed without delay.
