## Summary

This was a focused inspection, and on this occasion, we did not consider all themes in detail.

Children are happy, relaxed and enjoy their time at the setting. They are confident to express their ideas and opinions and can make decisions about how they spend their time. Children are developing positive relationships with their friends and staff. Children's independence is progressing well.

Children's needs are suitably considered. Staff review and implement a range of appropriate procedures to promote children's health and safety.

The setting is safe and secure for the children who attend. The people who run the setting recently undertook a review of procedures and have implemented several additional safety measures. There are suitable risk assessments in place although some require reviewing to ensure that they are robust.

The people who run the setting are committed to providing a quality service. There is a beneficial range of policies, procedures and documentation to support the running of the setting. People who run the setting have begun to update these to ensure they fully reflect recently reviewed practices.

## Well-being

All children have good opportunities to make choices and decisions about how they spend their time. They move freely between the indoor and the outdoor play environments. Children make choices between the many activities on offer and can follow their own interests. For example, when a child wanted to create a picture of a great white shark, the child decided to draw around a toy shark, proceeded to cut around the picture and used a stapler to join it all together. All children express themselves confidently, as they know their wants, needs and moods will be listened to. Children confidently and competently move resources around the environments, choosing where they feel most comfortable playing. We saw, children moving the tools from the dough table to aid their play in the water tray.

Nearly all children are happy, relaxed and enjoy their time at the setting. They are comfortable in their surroundings, familiar with daily routines and have a good sense of belonging. However, the midday routine was a little chaotic as some children eat their lunch, while others play in the area. During this time some children leave to go home, and others arrive. A few children became upset during this transition period.

All children enjoy their play and learning. They are enthusiastic and fully involved in the activities provided. All children have good opportunities to develop, learn and use their imagination to meet their developmental needs. Children concentrate for a good length of time in line with their age and stage of development. They enjoy one another's company and show interest in what their friends are doing. For example, two children were very busy working together to use a sticky tape dispenser. They stuck some tape onto a dinosaur, explaining how the dinosaur had hurt its head and they were putting a plaster on. Children play well together, chatting to each other and staff about what they are doing. We saw children completing puzzles with a staff member. They chatted happily, working together to find the pieces and taking turns.

Children are beginning to develop their independence skills, enabling them to do things for themselves. Many children access the toilet and wash their hands competently, while other children are offered support when needed. At mealtimes, children pour their own drinks and many open their own lunch boxes. This promotes children's self-help skills and builds their self-esteem.

As this was a focused inspection, we have not considered this theme in full.

Staff consider children's health and safety needs suitably. They follow procedures to accurately record staff and children's times of arrival and departure. Staff implement appropriate procedures to support children when recording, maintaining and reviewing records such as pre-existing injuries. Arrangements for nappy changing ensure children's privacy and dignity are respected. However, not all procedures followed by staff are detailed in the nappy changing policy. The infection control toolkit has been recently reviewed and appropriate practises have been implemented. For example, items stored in the bathroom are in sealed containers to minimise cross contamination.

#### Environment

As this was a focused inspection, we have not considered this theme in full.

The setting is safe and secure for the children who attend the setting. People who run the setting have recently reviewed and implemented several additional safety measures to ensure the entry and exit procedures are robust. There are suitable risk assessments in place and staff carry out daily safety checks of all areas. However, a few of these are not robust as they do not include all potential hazards. During the inspection we found a few emerging risks. For example, a small, raised pond did not have a cover, causing a potential hazard. However, immediate action was taken to address the issues.

## Leadership and Management

As this was a focused inspection, we have not considered this theme in full.

The people who run the setting are committed to providing a quality service and they respond positively to recommendations for improvement. There is a clear statement of purpose which provides parents with relevant information about the setting, so they can

make an informed choice. There are a beneficial range of policies, procedures and documentation to support the running of the setting. People who run the setting have begun to update any necessary documentation to ensure they fully reflect the setting's recently reviewed practices. This ensures that staff are provided with clear instructions as to what is required of them.
