Summary

Children are happy and enjoy their time at Cylch Meithrin Nantgaredig a'r Fro. They have a lovely sense of belonging and develop positive relationships and friendships. Children have good choices and make effective decisions about what they want to do. Children's interactions are warm, and they express enthusiasm and enjoyment in their activities. They feel settled and safe, forming strong bonds of affection with staff.

Nearly all staff understand and implement policies and procedures to keep children safe. Staff are kind towards children, providing positive interactions to ensure they feel valued and happy. They ensure children's needs are well met, providing some activities promoting independence and individual progress.

People who run this setting have measures in place to ensure the environment is safe and secure. There are play areas available for children to play indoors as well as an area outdoors. They ensure the environment meets the needs of children and enables them to access an appropriate range of age and stage appropriate resources to stimulate their imagination and interest.

People who run the setting manage it adequately. They ensure staff are supported suitably, however the system for ensuring staff suitability and professional development needs to be further developed.

Welsh is the main language used and the service provides the Welsh Language 'active offer'.

Well-being Good

Children are happy, express enthusiasm and enjoy their time at the setting. Children are familiar with one and other and have friends. They play happily together or alongside each other. For example, there is lots of chatting as children engage in an activity with the plastic building shapes. Most children speak or express themselves confidently. They communicate their needs in a variety of ways and know that staff will listen and respond appropriately. Children have opportunities to make decisions for themselves, for example, choosing which activities to play with and who to sit next to during snack time. Children's voice is acknowledged, for example children confidently state which song they want to sing before home time.

Children are familiar with the daily routines and this gives them a sense of security. They wash their hands at appropriate times. After their free play, children help tidy away the toys and sing, "Amser tacluso yw hi nawr". They approach staff with ease to make requests, for comfort or reassurance and to share stories about their families. Children's interactions are positive and they are praised for their achievements and efforts. Children are polite and they practice using good manners at times. They are learning to share and take turns well. For instance, when playing outside, children take turns on the slide and ride on toys; others play for a sustained period sharing the resources in the sand tray. They have strong bonds of affection with staff and during activity time, they enjoy sitting close to them as well as on their lap. Children are fully at ease and this was apparent as one child invited a staff member to sit by them during lunch time, "Dere i eistedd ar bwys fi."

Children are enthusiastic and gain a sense of achievement from their play and learning. They enjoy a good range of opportunities and move confidently from one area to another. We saw children participate and concentrate on self-chosen activities during the visit. However, photographs also evidence children taking part in some staff led tasks, for example celebrating Chinese New Year and planting seeds to grow potatoes.

Children have some opportunities to develop their independence skills enabling them do things for themselves successfully. For example, accessing the sink to wash their hands, placing wet wipes in the bin after wiping their faces, as well as tidying the toys and resources. Children gain a sense of pride from their achievements and smile as they receive praise from staff. Children support one another as they attempt to remove their coats independently after outdoor play.

Care and Development

Good

Nearly all staff fully understand and implement policies and procedures to promote healthy lifestyles and personal safety. They follow and implement policies, procedures and risk assessments. They follow cleaning routines thoroughly, for example, they clean the table prior to food and complete a thorough clean at the end of every session. Hand washing practices happen thoroughly and frequently with staff encouraging children or supporting them to do the same. Staff preparing food wear an apron and gloves.

All staff have up to date first aid training. They log relevant records of accidents and incidents; however, some parents signatures are missing. Discussion with staff demonstrate they understand the need for good safeguarding practice. However, not all staff members are confident on the procedure to follow if they had concerns and are not aware of The Prevent Duty. Not all staff have current training in child protection. Staff follow the nappy changing procedure as outlined in the policy.

Staff are qualified, and they care for children effectively and meet their individual needs well. They consistently implement positive behaviour management strategies, so children know what the expectations are. They use praise to reinforce good behaviour and promote development, "Da iawn ti. Good boi yn siarad." We did not observe any unwanted behaviour. Staff are consistently responsive and positive towards children. They listen to children's views and interact with children with warmth and kindness. They praise the children for their efforts with positive language and some staff members encourage them to be polite and say "Please" and "thank you". Staff create social periods for the children at mealtimes, however, they do not actively promote children's independence during snack time. The setting provides healthy snacks for the children.

Staff are a good example to the children as they speak kindly and respect each other. Staff respond lovingly to the children; they cuddle, embrace and make sure they meet their basic needs. Staff agree a theme and plan activities suitable for children. They ensure areas of learning are incorporated into the planning, however the development of skills do not always form part of the planning. We viewed samples of children's work and these were not dated. Staff assess children's progress and keep a written record of progress.

Staff told us they are very well supported and work well as part of the team. Staff use Welsh with children throughout the session, whilst taking part in activities and when giving praise and instructions.

Environment Good

The environment is safe, clean and in good condition, which provides a safe and comfortable place for children to relax and learn. The setting is secure and locked. Staff also keep a list of visitors to the cylch meithrin. People running the setting maintain a good environment to improve children's experiences. All safety checks on the equipment are up to date following the visit. Risk assessments were not available to view during the visit, however these were sent to Care Inspectorate Wales following the visit. Risk assessments identify risks and evidence that action is taken to reduce or remove these. There is a dedicated food preparation area which is kept clean and tidy. Children bring packed lunches from home for lunch, however these are stored at room temperature.

People who run the setting ensure there are thorough cleaning routines to maintain good hygiene practices and infection control methods. Fire drill records were not available to view during the inspection visit, however we were provided with records of these following the visit. These are carried out regularly and include the information required.

People who run the setting ensure children have access to an outdoor area, which provides a learning space and opportunities for children to explore. Resources for the outdoor area include a slide, ride on toys, mud kitchen, planting areas, plastic playhouses, balls as well as a wooden outdoor classroom and climbing structure. During the visits, staff provided children with plenty of opportunities for physical play outdoors.

People who run the setting ensure that all children have access to an appropriate range of good quality resources, which are rotated to ensure children have good variety and choice. They provide stimulating resources for all ages and stages of development to develop personal and social, language and mathematical skills through construction play, sensory activities, small world and role play activities. Children can access toys and resources easily, as they are stored openly and within their reach.

Leadership and Management

Adequate

Nearly all staff embed policies effectively in the running of the setting. There is a statement of purpose in place. This was updated during the inspection and is now compliant with regulations and National Minimum Standards. People who run the setting manage staff appropriately. They ensure staff are deployed in an organised way, so that they fully meet staffing ratios and children's needs. Staff members confirmed they are well supported in their roles. Staff receive one to one supervision and appraisals; however not all meetings are recorded. Performance management is not fully embedded as there were no records in place for all staff members during the visit. We were provided with further copies following the visit.

People who run the setting do not always follow thorough recruitment processes to safeguard children. They do not ensure all staff have up to date suitability checks. However, the people who run the setting took immediate action following the visit and ensured suitability checks were mostly in place. As a result, this is noted as an area for improvement and will be followed up in the next inspection. They provide an induction procedure for new staff, however they do not always promote ongoing training for professional development. A completed quality of care review is in place, which considers the views of service users. However, the review does not include the views of children and staff and does not identify ways for future development. Staff present during the inspection worked well as a team, all of whom were aware of their roles and responsibilities and led the children appropriately. As a result, children love the care provided by enthusiastic and caring staff.

Partnerships are sufficient. They ensure children are taken out to the local community and have also formed partnerships with a local business as well as residents. Parents of children using this setting tell us staff are caring and kind. Parents praise the service and told us, "I'm happy with everything. There's really good communication and my child loves coming." Another parent told us they receive plenty of verbal feedback in relation to their child's development as well as plenty of photographs through their social media page.
