Summary

Children are confident, happy and enjoy their time at Cylch Meithrin Parcyrhun. They have a lovely sense of belonging and develop positive relationships and friendships. Children have good choices and make effective decisions about what they want to do. Children's interactions are warm, and they express enthusiasm and enjoyment in their activities. They feel settled and safe, forming strong bonds of affection with staff.

Nearly all staff fully understand and implement policies and procedures to keep children safe. Staff are kind towards children, providing positive interactions to ensure they feel valued and happy. They ensure children's needs are fully met, and they assess children's abilities, providing activities promoting independence and individual progress.

People who run this setting have measures in place to ensure the environment is safe and secure. There are play areas available for children to play indoors and a shared area outdoors. They ensure the environment meets the needs of children and enables them to access a good range of age and stage appropriate resources to stimulate their imagination and interest.

People who run the setting have an innovative vision for the service and manage it relatively well. They ensure staff are well supported. The system for staff supervision and appraisal is not fully implemented.

Welsh is the main language used and the service provides the Welsh Language 'active offer'.

Well-being Good

Children are happy, express enthusiasm and enjoy their time at the setting. Children are familiar with one and other and have friends. They play happily together or alongside each other. For example, there is lots of chatting as children engage in an activity with the play dough indoors. Most children speak or express themselves confidently, communicating their needs in a variety of ways and know that staff will listen and respond appropriately. Children have opportunities to make decisions for themselves, for example, choosing which activities to play with and who to sit next to during snack time. During the visit, children confidently chose sandwiches and other snacks during a teddy bears picnic.

Children have a strong sense of belonging. They know the routines well. They wash their hands at appropriate times and help tidy toys away after use. They have strong bonds of affection with staff and enjoy sitting close to them as well as on their lap during activity time.

Children are enthusiastic and gain a sense of achievement from their play and learning. They enjoy a good range of opportunities and move confidently from one activity to another. Children participate and concentrate on self-chosen activities and in staff led tasks for appropriate periods of time. For example, painting outdoors.

Children have some opportunities to develop their independence skills enabling them do things for themselves successfully, for example using the step to access the sink to wash their hands as well as tidying their plates and cups after snack. Children gain a sense of pride from their achievements, and smile as they receive praise from staff.

Care and Development

Good

Nearly all staff fully understand and implement policies and procedures to promote healthy lifestyles and personal safety. They follow and implement policies, procedures and risk assessments. They follow cleaning routines thoroughly, for example, they clean the table prior to food. Hand washing practices happen thoroughly and frequently with staff encouraging children or supporting them to do the same. Staff preparing food wear an apron and gloves. We did not observe all staff members wearing an apron and gloves as they assisted children during mealtimes.

All staff have current training in child protection and up to date first aid. They log relevant records of accidents and incidents; however, some parents and staff signatures are missing. Discussion with staff demonstrate they understand the need for good safeguarding practice. Staff do not always follow the nappy changing procedure as outlined in the policy.

Nearly all staff are qualified, and they care for children effectively and meet their individual needs well. They consistently implement positive behaviour management strategies, so children know what the expectations are. They use praise to reinforce good behaviour. We did not observe any unwanted behaviour. Staff are consistently responsive and positive towards children. They listen to children's views and interact with children with warmth and kindness. They praise the children for their efforts with positive language and encourage them to be polite and say "Please" and "thank you". Staff create social periods for the children, including at mealtimes, and are a good example to the children as they speak kindly and respect each other.

Staff agree a theme and plan activities suitable for children. They ensure areas of learning and skills are incorporated into the planning. Staff assess children's progress and we saw children's targets displayed, however some targets set were broad and not very specific.

Staff told us they are very well supported and work well as part of the team. Staff use Welsh with children whilst taking part in activities such as counting and when giving praise and instructions.

Environment Good

People who run the setting ensure there are thorough safety measures in place. Access to and from the setting is secure and children are safe because no-one can enter or exit the setting without being admitted by a member of staff. Staff also keep a list of visitors to the cylch meithrin. All safety checks on the equipment are up to date. The person in charge had risk assessments in place during the inspection visit and these include Covid-19 measures. There is a small food prep area which is kept clean and tidy.

People who run the setting ensure there are thorough cleaning routines to maintain good hygiene practices and infection control methods. Fire drills are carried out, and a record is kept for these.

People who run the setting have access to a shared outdoor yard area to provide a learning space and opportunities for children to explore. Resources are taken out for each session and must be cleared away at the end of each session due to it being a shared area. During the visit, staff provided children with opportunities for physical play including ride on toys, balancing beams, creative play with paint and mark making opportunities with chalks, along with an opportunity to sit and look at a collection of books.

People who run the setting ensure that all children have access to a wide range of good quality, developmentally appropriate play and learning resources, in sufficient quantity, to ensure children have good variety and choice. They provide stimulating resources for all ages and stages of development to develop personal and social, language and mathematical skills through construction play, sensory activities, small world and role play activities. Children can access toys and resources easily, as they are stored at low level or within their reach.

Leadership and Management

Adequate

People who run the setting are committed to ongoing improvements and are eager in the management and operation of the service. There is comprehensive statement of purpose, however with changes in Covid-19 guidelines, this needed updating to reflect current practice.

Nearly all staff embed policies effectively in the running of the setting. People who run the setting manage staff appropriately and ensure that they are deployed in an organised way, so that they fully meet staffing ratios and children's needs. Staff members confirmed they are very well supported in their roles and there is an open-door policy if any issues arise. Performance management is not always effective. Staff receive one to one supervision and appraisals; however senior staff have not had their supervisions or appraisals completed regularly. As a result, this is noted as an area for improvement and will be followed up in the next inspection.

People who run the setting follow thorough recruitment processes to safeguard children. They ensure all staff have up to date suitability checks. They provide a good induction procedure for new staff, and they promote ongoing training for professional development. A completed quality of care review is in place, which considers the views of service users and identifies ways for future development. Staff present during the inspection worked well as a team, all of whom were aware of their roles and responsibilities and led the children appropriately. As a result, children love the care provided by enthusiastic staff.

Partnerships are sufficient. Parents of children using this setting tell us that staff are caring and kind. Parents praise the service, however they told us they do not receive much information on children's development, other than an end of year report as they transition to primary school. They told us that they are happy with the care and that staff are very approachable.

Recommendations to meet with the National Minimum Standards

- R1: Accident records are signed for by staff and parents/carers
- R2: The statement of purpose is updated to reflect changes in guidelines
- R3: Staff follow all policies and procedures stringently, for example the nappy changing policy
- R4: Staff provide specific targets for children, for example recognise and name a specific number
- R5: Staff are consistent with the use of personal protective equipment during meal times
