Children feel safe and happy at this setting. They feel comfortable and relaxed, as they know their choices and preferences are valued. Children's interactions are positive. They enjoy their play and learning activities. Children's independence is developing well.

The child minder keeps children safe and healthy. Interactions between the child minder and children are warm and calm. The child minder ensures children have a good selection of indoor and outdoor activities. She promotes children's play, learning and development well and records children's progress.

The child minder has suitable policies and procedures in place and ensures the environment is suitably safe, secure, and well maintained. She provides a range of play and learning resources to ensure children have a variety of choice. Resources are of good quality and condition.

The child minder is organised and runs the setting well. She seeks the views of parents to make improvements to her setting and completes an annual quality of care report. Partnerships with parents are good.

Well-being Good

Children have a strong voice. Their choices and preferences are valued. They play freely and decide what toys and activities they would like to play with from the good selection available. Children are effective communicators and make their own decisions. For example, they confidently chose what fruit they want to eat and decide which character they want to be when they role play.

Children feel safe and happy in the child minder's care. They positively engage and chatter away with the child minder, receiving nurturing and appropriate responses. Children are very settled, relaxed and feel quite at home. They display confidence with the child minder and are completely at ease with her and her family members. Children's artwork and photos are displayed in the child minder's home, promoting their sense of belonging.

Children's interactions are positive. They engage well with the child minder and each other. They smile and laugh as they chat and play happily. Children share toys and resources well. They enjoy listening to the child minder as she reads a book and use their imagination effectively when they role play a story. Children listen to instructions from the child minder well. For example, where to wait safely whilst she puts them in the vehicle.

Children enjoy their play and learning activities. They excitedly take part in story time and share resources well. They have good opportunities to initiate their own play and to influence their activities. Children can access toys that interest them and choose what to play with. Children's individual interests are taken into account and the child minder provides resources to enhance their experiences. For example, children enjoy the garage, vehicles and craft activities, which are available daily.

Children's independence is developing well. They are encouraged to do as much for themselves as possible in line with their age and stage of development. Children are able to help themselves to the toys in the boxes and at quiet time, are able to choose an age appropriate programme to watch whilst other children sleep. They eat independently and some children manage to wash and dry their hands with little support from the child minder.

### **Care and Development**

Good

The child minder keeps children safe and healthy. She is confident about her responsibilities to protect children. She responds well to safeguarding scenarios and understands the procedures to follow should she have a concern about children's safety or welfare. The child minder follows safe procedures during outings and ensures children are safely secured in the vehicle for transportation. She provides healthy snacks, meals and drinks. The child minder ensures children wash their hands at appropriate times and provides paper towels for drying. The child minder has appropriate records for any accidents or incidents and records the administration of medication. These are discussed with parents as appropriate and signatures obtained. She follows adequate nappy changing procedures; however, best practice is not always followed in line with infection control guidance. The child minder ensures children have plenty of outdoor play and fresh air.

There are positive relationships and interactions between the child minder and the children demonstrating respect, warmth and kindness. She manages children's behaviour and individual needs well. The child minder encourages children to share and to be kind. She resolves minor issues calmly and with ease. She praises good behaviour and children's achievements consistently which enhances and promotes their self-esteem. For example, when a child correctly identifies and places items in the correct area during a 'forest and recycling' activity.

The child minder provides a nurturing and caring atmosphere and gives responsive care. She maintains written developmental records, and plans for their next steps of development. She knows the children well and has a good understanding of each child's individual needs and routine. For example, she sits with children to read a book before settling them down to sleep or for some quiet time. The child minder promotes some basic incidental Welsh words.

**Environment** Good

The child minder ensures the environment is safe, secure and well maintained. A stair gate is situated at the bottom of the stairs, preventing children accessing the first floor. The child minder uses a visitors' book to record the people present when child minding takes place and identification badges are checked on arrival at the setting. The child minder provides a homely environment. She has developed appropriate risk assessments, which are reviewed regularly. However, the child minder had not identified all potential risks, such as the fire and surrounding hearth. The child minder completes regular fire drills with the children and keeps appropriate records. Heating safety checks are in place and cleaning routines reflect suitable hygiene practices.

The property is clean and welcoming. The child minder uses her kitchen/dining area, living room and playroom for child minding. The toilet is situated on the ground floor and the child minder ensures she supervises and supports the younger children when required. The child minder organises the environment appropriately to provide a good range of play opportunities for children and there is suitable space for the age ranges cared for. There is a secure outdoor garden which children can access from the playroom and provides children with regular opportunities for fresh air and physical play. The garden is split level with a lower patio area and a raised grassed and second patio area. The child minder told us that she is considering sectioning off the garden to provide separate areas of play for the children. We did not see the children play in the garden during our visit.

The child minder ensures children can access a variety of age-appropriate furniture, toys, and equipment. She provides a range of resources for the children, including creative, role play, language, and small world resources. There are plenty of toys to keep the children's interest. Storage boxes are stored at low level so that children can easily identify the contents and help themselves. The child minder promotes an awareness of different cultures and diversity with resources such as books and celebrates some festivals such as Diwali.

### **Leadership and Management**

Good

The child minder is organised and runs her service appropriately. She engages positively with Care Inspectorate Wales and addresses any recommendations. The child minder has an up to date statement of purpose which reflects the service provided. She has a range of suitable policies and procedures, which she reviews regularly. The child minder ensures that children's records and documentation are accurate and complete, including a range of permission forms and a children's register. The child minder has up to date certificates such as public liability insurance, Information Commissioner's Office and car documents.

The child minder reviews and reflects upon her service and produces a quality of care report. She seeks information from parents to support her in the evaluation of her service and provides an opportunity for them to make any suggestions for improvements. The child minder is committed to developing her business to ensure that she provides a good quality service. The child minder has an action plan which considers making improvements to the rear garden and purchasing additional resources for children to benefit them further.

The child minder is suitably qualified and has completed the required training courses, such as safeguarding, first aid and food hygiene. She is committed to developing her own professional development by attending various training courses such as promoting children's voice through photography, additional learning needs and enhanced play training. Disclosure and Barring Service checks (DBS) for herself and household members aged over 16 years are valid.

The child minder promotes positive partnerships with parents. She keeps parents up to date regularly through verbal communication and electronic means. The child minder makes good use of her local community. For example, she takes children to the library and on trips to various places such as parks and the beach, which benefit the children's development and learning. The child minder successfully works closely with other child minders in the area.
