Summary

This was a focused inspection and on this occasion, we did not consider all themes in detail.

Children are happy and relaxed at the setting. They have good relationships with staff, showing trust and warmth. Children behave kindly and considerately, communicating effectively with both adults and their peers. They are independent and confident in their own abilities.

Staff keep children safe through implementing suitable routines and procedures. They interact in a kind and caring manner with the children in their care. They work well together to support children and ensure that their individual needs are met.

People who run the setting are keen to raise standards to ensure the provision of a high-quality service. They responded quickly to make changes to improve their record keeping during this inspection. Staff we spoke with expressed that management was supportive.

Well-being

As this was a focused inspection, we have not considered this theme in full.

Children are confident to speak, express themselves and communicate their needs. They have opportunities to make choices about how they play. For example, we saw children moving back and forth between singing activities with staff and toys of their choice. They approach adults confidently to show them what they are doing, make requests or engage in conversation.

Children are happy and well settled. They have warm relationships with staff and readily approach them for guidance or comfort. For example, babies reach for staff when a little uncertain of our presence or for a cuddle on waking from their nap. They respond well to reassurance from staff which boosts their self-esteem and feeling of belonging.

Children behave kindly and considerately, communicating effectively with both adults and their peers. Babies take turns and share very well for their ages, showing consideration and care as they pass a toy around. Older children chatter happily as they eat their snacks.

Children are content with the resources and activities available to them. They are self-motivated to initiate their own play and share their thoughts on what they are doing. For example, babies babble excitedly in conversation with staff about their toys and dance to music together.

Children have opportunities to develop their independence skills through a variety of play and learning experiences. Babies develop their coordination through pulling themselves up and stacking blocks. Older children wash their hands and eat with good independence.

Care and Development

As this was a focused inspection, we have not considered this theme in full.

Staff follow procedures to ensure children are safe and healthy. They clean tables effectively before food times and wear aprons to serve food. They take good precautions to ensure allergies are managed well.

Staff have warm relationships with children. They speak fondly of them and use praise and encouragement to provide reassurances and boost confidence. Staff interactions with each other and children are respectful. They use sensitive methods of behaviour management. Many staff members use very effective methods to engage and interest children.

The setting has a clear additional learning needs procedure and policy that sets out expectations and processes for the identification and management of needs. People who run the setting have a good understanding of this and record relevant information appropriately.

Leadership and Management

As this was a focused inspection, we have not considered this theme in full.

People who run the setting are committed to improving standards for children and families. They were very responsive to discussions with us. Staff we spoke with were enthusiastic and felt that management were approachable.

In the main, people who run the setting ensure that staff are deployed effectively. On most days, a suitable number of qualified staff care for children, but on a few occasions the requirement of the national minimum standards has not been met in relation to the ages of the children.

Children's attendances are recorded electronically but staff and people who run the setting identified that this is not always effective. It was not always clear when children had moved to a different base room and the Wi-Fi connection was insufficient to ensure that all children were registered promptly. Following our visit, people who run the setting have revised this process and will now use paper registers. They now need to imbed and review the efficiency of this system.
