

Children have a strong voice and the majority are generally happy and settled. They know their needs and preferences are considered. Children's interactions with staff are positive, and many children show positive interactions with each other, with some exceptions. Many children enjoy their play opportunities and show good independence skills.

Staff are aware of the policies and procedures to keep children healthy. However, safeguarding arrangements are not always effective in practice. Staff provide positive, fun and kind interactions with children. However, due to lack of supervision and staff to child ratios, some policies and procedures are not always fully implemented to manage children's interactions and behaviours effectively.

Leaders have some arrangements to make the environment safe and secure for children. However, not all environmental risks and hazards are eliminated so far as possible. Leaders ensure the building is well ventilated and accessible. However, the procedures to reduce the risk and spread of infection in toileting areas are not effective. Leaders have a range of adequate resources and use the local area to provide outdoor experiences for children. However, the range of resources for some age ranges and interests are limited.

Leaders have not ensured regulatory requirements, policies and procedures are sufficiently implemented and embedded to safeguard children. They have not ensured that they meet the conditions of registration, they have failed to complete staff suitability checks and therefore we have issued priority action notices. Partnerships with parents are effective.

Well-being Adequate

Overall, the majority of children are generally happy and settled at the setting. Older children arrive relaxed and feel confident engaging with leaders and staff. However, on arrival, many of the younger children needed comfort to settle within their surroundings. Children confidently help themselves to resources of interest. They move around from the indoor and outdoor areas with ease and confidence.

Children have a strong voice. They know their needs and preferences are considered and respected by staff. For example, children sit where they desire at lunch and snack times, and they can choose to eat when they are ready. Children are confident to ask for resources of their choice if they are not readily available, for example, they asked for paper to do some colouring, and this was acted upon by staff.

Children's interactions are mainly positive. They share resources such as dolls and crayons successfully. Children have positive relationships with staff. They chat about their families and friends during play and whilst eating food. Younger children give staff members hugs and engage with them when they need support to complete a jigsaw, and when they need support to carry out tasks and activities. However, the lack of supervision and sufficient resources to entertain older children results in some children falling out and becoming upset at times.

Children enjoy their play opportunities. Most children enjoy playing the resources available to them. For example, they play with the toy cars, dolls and prams imaginatively. Outdoors, they play with the mud kitchen, bean bags, hoops and balls. Older children told us that they enjoy playing in the park. However, they also told us when they don't go to the park, they play games on their phones and take pictures of each other and send these to their friends. Due to the wet weather on the day of the inspection, children did not have access to the park.

Children show independence in their ability to access resources and manage their personal hygiene needs.

Care and Development

Adequate

Staff are aware of the policies and procedures to keep children healthy. They ensure children wash their hands before snack time, and staff follow hygiene procedures appropriately when they prepare mid-morning toast. However, staff provide children with one towel to share when they dry their hands and there was no individual towels available. The children did not have the opportunity to wash their hands with soap and water before lunch time; they provided a hand sanitiser instead. Staff ensure children always have access to their personal water bottles. They are fully aware of the policies and procedures relating to safeguarding if there was a child welfare concern. However, as leaders do not provide sufficient staffing on all occasions and the adult to child ratios are not always met: this impacts on children. Leaders and staff informed CIW that there is a suitable number of staff available who have paediatric first aid, safeguarding and food hygiene training. Incidents, accidents and pre-existing injuries are recorded.

Staff provide positive, fun and kind interactions with children. They ensure children who arrive at the setting are comforted and they successfully settle them with suitable distractions, effectively knowing the children's preferences. Staff manage children's behaviours as far as possible. However, due to lack of supervision and staff to child ratios, the behaviour management policies and procedures are not fully always implemented.

Staff know the children well. They manage to celebrate children's achievements. For example, they celebrate that children have successfully completed a jigsaw. Staff ensure that the Welsh language is promoted and always encouraged through play and discussion. They provide a free play environment for children from the inside to the outside areas of the premises.

Environment Adequate

Leaders make some arrangements to ensure the environment is safe and secure. They ensure gates are locked, and they eliminate some risks in the outdoor area with temporary fencing. Environmental maintenance checks are regularly conducted. However, not all environmental risks are eliminated, and risk assessments do not identify or eliminate potential risks to children's health and safety. For example, they do not include the risks to children within the setting, outdoor area or the supervision requirements and risks in or near the park. On arrival at the setting, the toilet area was found not clean: there was a dirty towel, mop and bucket, hazardous chemicals and a screwdriver within reach of children. In addition, leaders have not ensured that fire drills are conducted since the setting was established and a clear record of children attending is not always available for cases of emergency. This has an impact on children and have been identified as an area for improvement, and we expect the provider to take action.

Leaders ensure the building is well ventilated and accessible. The setting is located within a chapel vestry. It is spacious indoors and a reasonable space outdoors. Toilets are available with liquid soap. However, as the provider has operated over the registered numbers on occasions, there is not always a sufficient number of toilets for the number of children attending.

Leaders have an adequate range of resources which ensure children who are interested in small world and role play are effectively engaged in their play. There are puzzles, pencils and crayons as well as physical play resources, including a bouncy castle. Leaders make use of a nearby park when the weather permits. However, resources for older and interests of the youngest children are limited.

Leadership and Management

Poor

Leaders have not ensured regulatory requirements, policies and procedures are sufficiently implemented and embedded to safeguard children, and this has resulted in poor outcomes for children.

Leaders have adopted policies and procedures in principle from a third-party organisation however they are not a member of the organisation. They have not purposefully reviewed and tailored them to ensure the policies relate fully to their service. There are no signatures or dates on these, and the safeguarding procedures do not have a named designated safeguarding officer. Leaders ensure that records sometimes reflect the attendance of children and staff present. However, these are not always recorded sufficiently and accurately. On the day of inspection, the number of children present was not reflected accurately in the records, which were then amended by leaders, when prompted. The number of staff to child ratio is not always met and therefore the safety and needs of children are not always met. Staff are not able to adequately safeguard and supervise children at all times. On the day of inspection, not all children were suitably supervised due to lack of staff to child ratios. This is placing people's health and well-being at risk, and therefore we have issued a priority action notice. Contracts are signed by parents. However not all permissions are in place for outings, and do not permit children to play with online games and take pictures. Leaders have a current public liability insurance.

Leaders have ensured they inform CIW about significant changes and events. However, they have only recently, during the inspection, made amendments to the statement of purpose, which now reflects the current running of the setting. Leaders have not ensured that they meet the conditions of their registration. They have exceeded their registered numbers. This is placing people's health and well-being at risk, and therefore we have issued a priority action notice.

Leaders have ensured they employ staff who are qualified and a suitable number of staff have the mandatory training requirements, which are up to date. However, a relevant person does not have the required playworker qualification and does not have suitable safeguarding training. Suitability checks are in place for one member of staff who runs the setting. However, the registered person has not ensured all suitability checks had been obtained for all other staff prior to them starting to work with children at the setting. Disclosure and Barring Service (DBS) checks for the most of staff members were obtained prior to employment. DBS details provided for a few members of staff members were not correct and had not been sought. They have been applied for during the inspection. This has placed people's health and well-being at risk, and therefore we have issued a priority action notice. Since the inspection, leaders have obtained DBS checks for the members of staff. Staff enjoy working at the setting and feel they work together as a family. They confirmed that they are supported by their leader, they receive supervisions, and further training is acted upon.

Partnerships with parents are strong. Leaders ensure there is a webform app to communicate with parents about the children and the organisation of setting. They feel their children enjoy the activities on offer and feel their children's needs are met. Parents feel that their children have a brilliant time with very caring staff who go above and beyond to make sure their children have a good time.
